

AMENDMENT NUMBER ONE TO CONTRACT NUMBER RCA-017-21010021 FOR

UNLEADED FUEL AND RELATED SUPPLIES AND SERVICES

This Amendment Number One ("Amendment") to Contract Number RCA-017-21010021 is made and entered into upon execution of all necessary signatures between the County of Orange, a political subdivision of the State of California, ("County") and Pinnacle Petroleum Inc., with a place of business at 16651 Gemini Lane, Huntington Beach, CA 92647 ("Contractor"), which are sometimes referred to individually as "Party" or collectively as "Parties".

RECITALS

WHEREAS, County and Contractor executed Contract Number RCA-017-21010021 for Unleaded Fuel and Related Supplies and Services, effective July 1, 2021 through June 30, 2026 ("Contract"); and,

WHEREAS, the County desires to amend Attachment B "Compensation and Fees", Section III "Fuel Prices and other fees" to increase pricing, effective March 1, 2022, and,

NOW, THEREFORE, the Parties mutually agree to amend the Contract as follows:

Wherever a conflict in the terms or conditions of this Amendment and the Contract including earlier amendments exists, the terms and conditions of this Amendment shall prevail. In all other respects, the terms and conditions of the Contract, including its earlier amendments, remain unchanged, in full force and effect.

In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signator to bind the corporation.
