AMENDMENT NUMBER ONE TO CONTRACT NUMBER RCA-017-18010045 BETWEEN COUNTY OF ORANGE

AND

UNITED SITE SERVICES OF CALIFORNIA, INC. FOR

PORTABLE TOILETS/SHOWERS AND OTHER SITE RENTALS AND SERVICES

This Agreement, hereinafter referred to as "Amendment", is made and entered into upon execution of all necessary signatures, between the County of Orange, hereinafter "County" and United Site Services of California, Inc. with a place of business at 4511 N. Rowland Ave., El Monte, CA 91731, hereinafter referred to as "Contractor", which are sometimes individually referred to as "Party" or collectively referred to as "Parties":

RECITALS

WHEREAS, County and Contractor entered into a Contract RCA-017-18010045 (hereinafter "Original Contract") on June 22, 2018 for Portable Toilets/Showers and Other Site Rentals and Services, to commence on July 1, 2018 through and including June 30, 2023; and,

WHEREAS, County desires to revise original terms and conditions; Article Q "Change of Ownership" with "Change of Ownership/Name, Litigation Status, Conflicts with County Interests";

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both County and Contractor agree to amend Contract as follows:

1. Article Q is amended as follows:

Q. CHANGE OF OWNERSHIP/NAME, LITIGATION STATUS, CONFLICTS WITH COUNTY INTERESTS

Contractor agrees that if there is a change or transfer in ownership of Contractor's business prior to completion of this Contract, and the County agrees to an assignment of the Contract, the new owners shall be required under the terms of sale or other instruments of transfer to assume Contractor's duties and obligations contained in this Contract and complete them to the satisfaction of the County.

County reserves the right to immediately terminate the Contract in the event the County determines that the assignee is not qualified or is otherwise unacceptable to the County for the provision of services under the Contract.

In addition, Contractor has the duty to notify the County in writing of any change in the Contractor's status with respect to name changes that do not require an assignment of the Contract. The Contractor is also obligated to notify the County in writing if the Contractor becomes a party to any litigation against the County, or a party to litigation that may reasonably affect the Contractor's performance under the Contract, as well as any potential conflicts of interest between Contractor and County that may arise prior to or during the period of Contract performance. While Contractor will be required to provide this information without prompting from the County any time there is a change in Contractor's name, conflict of interest or litigation status, Contractor must also provide an update to the County of its status in these areas whenever requested by the County.

The Contractor shall exercise reasonable care and diligence to prevent any actions or conditions that could result in a conflict with County interests. In addition to the Contractor, this obligation shall apply to the Contractor's employees, agents, and subcontractors associated with the provision of goods and services provided under this Contract. The Contractor's efforts shall include, but not be limited to establishing rules and procedures preventing its employees, agents, and

- subcontractors from providing or offering gifts, entertainment, payments, loans or other considerations which could be deemed to influence or appear to influence County staff or elected officers in the performance of their duties.
- **2.** All terms and conditions contained in this Amendment are incorporated by this reference into the Contract. This Amendment modifies the Contract only as expressly set forth above. This Amendment does not modify, alter or amend the Contract in any other way whatsoever.
